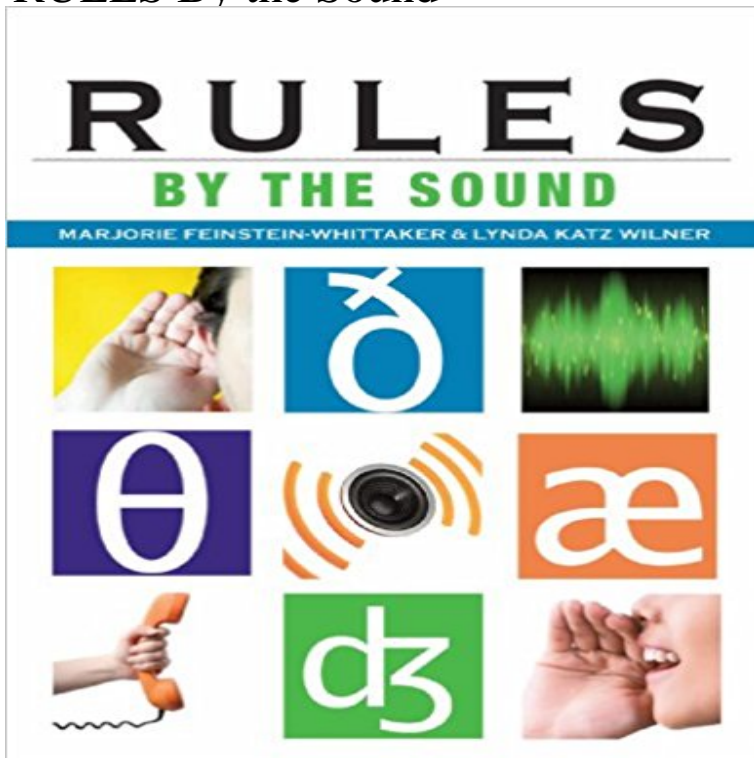


RULES By the Sound
