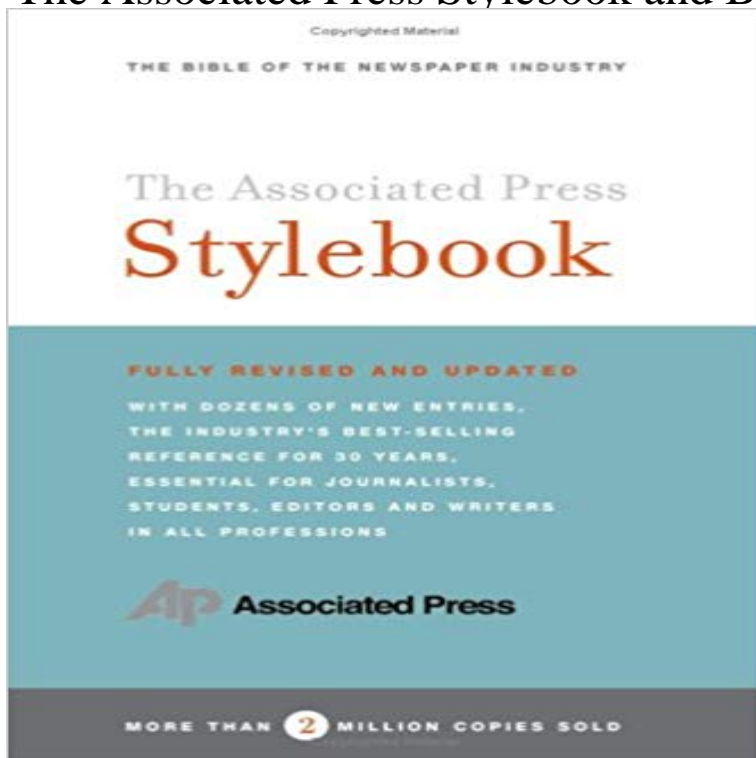


# The Associated Press Stylebook and Briefing on Media Law
